Conc.: Appointment of Chairs and Vice-Chairs of CEEP Committees

Please note that the mandates of the majority of Chairs and Vice-Chairs of CEEP Committees are coming to a term in October 2010. Taking into account that a CEEP General Assembly is planned for 15 December 2010, we suggest that the current mandates (list attached) are prolonged until that date. With the present letter we would however like to ask you to already prepare proposals for candidates for the term December 2010 to December 2013. See attached form.

We would like to draw your attention to two points:

- The “Services of General Interest & Statistics” (SGI & STAT), “Local Enterprises” (LE), and “Enterprises, Competition and Internal Market” Committees jointly decided in the meeting of the Chairs, Vice-Chairs and General Rapporteurs held jointly with the General Assembly on 10 December 2009 to hold joint meetings during 2010. At the end of that period, the decision should be taken on whether to merge the three Committees into one or to simply keep the habit of holding joint meetings. We would kindly ask you to indicate your preference as a National Section and to send us your proposal accordingly (either a proposal for a Chair and Vice-Chairs of a merged Committee, or individual Chairs and Vice-Chairs for each of the three Committees). See attached form.
- The mandates of the Social Affairs, Energy and Water Committees are not synchronised with the others due to historical circumstances. Their terms expire in September 2011. In order to allow the full synchronisation of all mandates from 2013 onwards, we would like to propose that, once those mandates come to an end, the new mandates shall run until December 2013. In order for a final agreement on this procedure to be made in time for the General Assembly meeting of 15 December 2010, please complete the attached form.
